1) **CSR Policy**

PNB MetLife believes in being a good corporate citizen and showing its commitment to the communities in which it lives and does business with. The CSR program has been built around the strategy of leveraging on the MetLife Foundation's expertise, research and evaluation around the key issues facing the community and the Company's geographical strengths (partners) to facilitate project management and volunteering. 
