| 1. | <b>Owner of the Policy</b>       | The Owner of the Policy, subject to the provisions of section 2(2) of the Insurance Act, 1938, may or may not be the Insured. An owner other than Insured would be someone (either an Individual or a company) who is purchasing the Policy for the Insured.   |
| 2. | <b>Understanding this Policy</b> | <p>“You” and “your” refer to the Owner of the Policy.</p> <p>"Owner" refers to the holder of the Policy.</p> <p>“We”, “us”, “our” and "Company" refer to MetLife India Insurance Company Private Limited.</p> <p>"Application" refers to the Proposal Form as defined under the Insurance Regulatory and Development Authority (Protection of Policyholders' Interest) Regulations 2001.</p> <p>“Insured” named in the Schedule is the person on whose death / survival, or happening of any other insured event, the benefits as defined in the Schedule, subject to the terms and conditions of this Policy, will become payable.</p> <p>"Beneficiary" refers to the person(s) nominated by the Insured to receive the insurance proceeds in accordance with the provisions of Section 39 of the Insurance Act, 1938.</p> <p>The "Contingent Beneficiary" is the Person(s) named to receive insurance proceeds in case the Beneficiary is not alive.</p> <p>“Date of attaining majority” is the date on which the Insured attains Age 18.</p> <p>“Policy Renewal Date” is one year from the Effective Date of the Policy and every date falling one year thereafter till the Date of Maturity.</p> |
| 3. | <b>Proof of Age</b>              | <p>The age of the Insured is based on the proof of age submitted and the premiums are calculated on the last birthday prior to the date of commencement of the risk under the Policy. Should the actual age of the Insured differ from the age stated in the Application, we shall, without prejudice to the statutory rights and/ or remedies we may have, be entitled to the following at any time during the policy term:</p> <ul style="list-style-type: none"> <li>✓ If the actual age proves to be higher than what is stated in the Application, the Face Amount of Insurance would be adjusted to that which would have been purchased by the amount of premium paid, had the age been correctly stated; or</li> <li>✓ If the actual age is lower than that stated in the Application, the premium paid in excess will be refunded to the Owner without interest or may be adjusted towards future premium. The Policy will continue to be in force as per the terms specified therein; or</li> <li>✓ If the Insured’s actual age is such that it would have made him/ her ineligible for the insurance cover stated in the Policy,</li> </ul>   |

| 4.  | <b>Currency and place of payment</b> | All amounts payable either to or by us shall be in Indian Rupees and will be payable at the Head Office, Regional Office or any other office of the company, which may be notified by us from time to time.   |
| 5.  | <b>Benefits Payable</b>              | On the happening of the Insured event, the following benefits will be payable:<br><br><b>A. Death Benefits:</b><br>100% of face amount plus rider benefit if any.<br><b>B. Survival Benefits:</b><br>100% of face amount payable on attaining age 100 (last birthday).  |
| 6.  | <b>Suicide Exclusion</b>             | In the event the Insured commits suicide, whether sane or insane at that time, within one year from the effective date of insurance cover or the date of the Policy or the date of the last reinstatement whichever is later, the insurance cover shall be void and we shall not be liable to pay the Face Amount of Insurance, except refunding the premium(s) received without interest, if any, less any expenses incurred by us.                |
| 7.  | <b>Premium Payment</b>               | The benefits of this Policy depend on the payment of premiums when due. Premiums are payable while the Insured is alive and are payable on or before their due dates as shown in the schedule.<br>The frequency of payment may be changed with our prior written approval effective from the following policy renewal date.   |
| 8.  | <b>Grace Period</b>                  | If premiums are not paid on its due date a Grace period of 30 (thirty) days will be allowed for payment of premium without interest. During the Grace period the Policy shall continue to be in force for all the Insured events. If the premium is not paid within the grace period, the policy shall lapse and shall not be subject to non forfeiture.  |
| 9.  | <b>Automatic Premium Loan</b>        | Each premium which remains unpaid at the end of a grace period will be paid with an automatic loan if:<br>a. You ask us to do so in the application for your policy or in writing while no premium is due and unpaid; and<br>b. Your policy has enough Guaranteed Surrender Value to pay the premium.<br><br>This is subject to any policy loan already availed and accrued interest thereon.   |
| 10. | <b>Reinstatement</b>                 | The owner of the policy may reinstate the Policy while the insured is alive if he/she <ul style="list-style-type: none"> <li>• Requests in writing for reinstatement with in 3 years from the date of the Policy lapsed.</li> <li>• Provides enough evidence of insurability to us.</li> <li>• Pays all due premiums to date of reinstatement with compound interest at the rate prescribed by the company at the time of Reinstatement.</li> </ul> |

| <p>11.</p> | <p><b>Guaranteed Cash Surrender Value</b></p>                     | <p><b>For Limited Pay Options:</b> The Policy has a guaranteed surrender value period provided:</p> <p>a) The policy has been in-force for at least three years; and<br/>b) All premiums have been paid for three full years.</p> <p>The policy acquires a surrender value which will be at least equal to 30% of the premiums paid excluding the first year premium, extra premiums and rider premiums, if any.</p> <p><b>For Single Pay Option:</b> The policy acquires a surrender value which will be at least equal to 90% of the premium paid excluding extra premiums and rider premiums, if any.</p> <p>Surrender value is payable only from the end of the second policy year.</p> <p>The Guaranteed Surrender Value payable will be subject to any statutory or any other restrictions as may be applicable. The policy can be surrendered to the Company for its full Guaranteed Surrender Value</p>   |
| <p>12.</p> | <p><b>Policy Loan</b></p>   | <p>While a policy is in force (except in the case of reduced paid-up insurance) and provided that it has a guaranteed surrender value the owner of the policy can raise loan from the Company. If there is an existing loan the owner of the policy can increase it. The maximum amount of policy loan is limited to 90% of Guaranteed Surrender Value at the end of the relevant policy year less any unpaid premiums for that year and loan interest accrued to the end of that year. The policy must be assigned in favor of the Company.</p> <p>Loan interest is charged daily at a rate the company sets from time to time. When a loan is made, the company will inform the owner of the policy of the rate of interest to be charged. The company will mail a notice to the owner of the policy at least thirty days before effecting any rate increase that will apply to an existing loan.</p> <p>Loan interest is due at the end of each policy year. Interest not paid within thirty days after it is due will be added to the loan principal. It will be added as of the due date and will bear interest at the same rate as the outstanding loan amount.</p> |
| <p>13.</p> | <p><b>Loan Repayment</b></p>                                      | <p>Repayment of all or part (but not less than Rs. 500) of a policy loan may be made at any time while the Insured is alive.</p>  |

| 16. | <b>The Contract</b>                     | This Policy document, application and declaration and the riders attached are all part of this contract.   |
| 17. | <b>Travel, residence and occupation</b> | This Policy does not impose any restrictions as to travel, residence or occupation, except as otherwise provided in any special provisions to this Policy or by law.   |
| 18. | <b>Beneficiary</b>                      | <p>The Beneficiary/ Beneficiaries is/ are the person or persons the Insured may nominate, to whom the insurance proceeds are payable upon death of the Insured.</p> <p>A contingent Beneficiary/ Beneficiaries may also be named by the Insured to become the Beneficiary/ Beneficiaries if the Beneficiary/ Beneficiaries die while the Insured is alive.</p> <p>While the Insured is alive, the Insured may change any Beneficiary or contingent Beneficiary.</p> <p>If more than one Beneficiary is alive when the Insured dies, the benefits will become payable in equal shares unless you have chosen otherwise.</p> <p>Where the beneficiary is a minor, the Insured may appoint any person to receive the benefits payable during the minority of the beneficiary.</p>   |

| 20. | <b>Claims Procedure</b>                 | <p><u>Maturity Claims</u></p> <p>We shall settle the maturity claim on the date of maturity, after deducting outstanding policy loan and accrued interest thereon, provided the Insured is alive on that date, has paid all the installment premiums including interest, if any, till the date of maturity and submits the following documents to us: -</p> <ul style="list-style-type: none"> <li>✓ The Original policy document</li> <li>✓ The Claim forms as prescribed by us</li> <li>✓ The discharge voucher as prescribed by us</li> </ul> <p>We shall settle the maturity proceeds to the Insured or the assignee, as the case may be.</p> <p><u>Death Claims</u></p> <p>Upon death of the Insured before the date of maturity, we shall settle the death claim, after deducting outstanding policy loan and accrued interest thereon, on submission of the following documents, provided all premiums fallen due till the date of death have been paid:</p> <ul style="list-style-type: none"> <li>✓ The Original policy document.</li> <li>✓ The Claim forms as prescribed by us</li> <li>✓ Written Intimation of death by the Beneficiary/ legal heir</li> <li>✓ Official death certificate issued by a competent authority</li> </ul> |

Complaints to the "Ombudsman" can lie only when we have rejected the complaint or no reply was received within one month of the complaint or the reply was not satisfactory. A complaint can be made to the ombudsman within one year after we have rejected the representation.</p> |
| 22. | <b>Disclosure</b>                      | <p>This Policy has been issued on your representations that you have made full and accurate disclosures of all material facts and circumstances and that you have not misrepresented or suppressed any material facts or circumstances. In the event it comes to our knowledge that you have misrepresented or suppressed any material facts and circumstances we shall reserve the right at our sole discretion to take such action, as we deem appropriate including cancellation of the Policy and forfeiture of premium(s) received.</p>  |
| 23. | <b>Incontestability</b>                | <p>In accordance with the provisions of Section 45 of the Insurance Act, 1938, except for fraud, misrepresentation of any kind or non-disclosure or suppression of material facts, this policy will be incontestable by the Company after it has been in force during the lifetime of the Life Insured, for two years from the date of policy.</p>  |
